Your package will entitle you to up to 2 cycles of IVF or IVF with ICSI, and your entitlement from the package will stop after you have a baby.

All embryos from a cycle must be transferred before you can move to the next cycle. The cycles must be completed within a year of starting the first cycle of treatment.

Medication is not included in the package price and will be based on your individual treatment plan.

*If you need to upgrade from the IVF to the ICSI package, ICSI can be added to your remaining cycles at the fee in our price list. If a cycle is canceled before egg collection, you will be entitled to a repeat cycle (up to one cancellation per package). If you withdraw completely from the package before your first egg collection, there will be a refund of the amount paid less **£1400***

What if I don't complete treatment?

It is sometimes necessary to discontinue treatment for medical reasons. Under these circumstances we may refund/partially refund your treatment costs or provide you with a credit note towards your next treatment cycle. Please note that we do not refund any of the costs relating to the pre-treatment procedures or drugs.

In-vitro Fertilisation (IVF) Cycle

If an IVF cycle is discontinued on the advice of an In-OVO Fertility Clinic Consultant, for medical reasons after stimulation has commenced but before the egg collection procedure we will refund you the full cost of the IVF Treatment Package less £1400. This is to cover the cost of administration and nursing care up to this point.

If your IVF treatment is stopped on the advice of an In-OVO Fertility Clinic Consultant, for medical reasons prior to transfer of your embryos, requiring the freezing of the embryos created in the treatment cycle, **the cost of the first frozen embryo transfer following a FAE (freezing of all embryos) will be reduced by 50%.**

Blastocyst Culture and Embryoscope Flex

In case that the none of the embryos reach the blastocyst stage, there will be no refund for either the Blastocyst culture or the use of Embryoscope Flex, as In-OVO Fertility Clinic's policy is to include these in the package treatments free of charge as they offer the best chances to achieve a pregnancy.

Fees and Payment Details

Comprehensive financial information is provided at your first consultation. A general guide to when payments are due is shown below:

All assisted conception treatment cycles are required to be registered with the Human Fertilisation & Embryology Authority (HFEA). The HFEA charge a registration fee that becomes due at the start of a treatment cycle. This charge has been included in the treatment package price.

Payment may be made in full by debit or credit card, or bank transfer. Credit card payments are accepted over the telephone and if the amount payable is above £500 it incurs a 1% bank charge.

We accept most major credit or debit cards and bank transfers.

These Terms and Conditions apply to all services provided to you by In-OVO Fertility Clinics Limited. The health and wellbeing of our patients is at the core of our values, making it our priority to provide you, our patient, with high quality personalised treatment. Please take the time to read this document and do not hesitate to contact us if you have any questions. We reserve the right to modify these Terms and Conditions at any time.

AGREED TERMS

APPLICATION

These terms and conditions will apply to the purchase of the services by you (the Patient or you).

We are In-OVO Fertility Clinics Limited a company registered in Northern Ireland under the number NI616463 whose registered office is 1Murray House, Murray Street, Belfast BT1 6DN (the Supplier or us or we).

These are the Terms and Conditions on which we provide all Services to you. By requesting any of the Services, you agree to be bound by these Terms and Conditions.

INTERPRETATION

The definitions and rules of interpretation in this condition apply in these terms and conditions (Conditions).

Contract: The Patient's request for the provision of Services/Treatment from In-OVO Fertility Clinics Limited, and our agreement to provide the Patient with such.

Patient: The person(s) receiving goods and/or services from In-OVO Fertility Clinics Limited.

Services/Treatment: The Services to be provided by us under the agreement and as set out in the treatment plan held within the Patient Notes, and which may be amended or adjusted during the course of any such treatment.

Patient Notes: The records made during any consultation (be that initial or subsequent). **Prices:** The fees applied to the Services, and/or Treatment provided by In-OVO Fertility Clinics Limited, as set out in the Price Guide, website, Costed Treatment Plan (Invoice), or as otherwise advised to the Patient on an individual basis by us.

APPOINTMENTS AND SERVICES

The description of the Services is as set out on our website, brochures, price guide, treatment plan, or any other form of advertisement.

All Services are subject to availability of Clinic staff. We cannot guarantee that you will be seen by the same clinician at each appointment, and whilst we endeavour to, nor can we guarantee that all appointments will run to time.

In the event of a patient not keeping an appointment or cancelling with less than 24 hours' notice, In-OVO Fertility Clinics Limited reserves the right to charge the full price for that appointment.

In the event of cancellation of an appointment by In-OVO Fertility Clinics Limited, the Patient will be given as much notice as possible, and will offer alternative times for the appointment to be re-scheduled.

IN-OVO FERTILITY CLINICS LIMITED RESPONSIBILITIES

Due to the complex nature of fertility treatment, In-OVO Fertility Clinics Limited cannot take responsibility for an unsuccessful final outcome in the provision of our Services, nor can we guarantee that any Treatment will be without complications.

We will endeavour to provide all Services in accordance with the Treatment Plan, which has been deemed by all parties as appropriate for you, the Patient. The Treatment Plan will form part of the Patient Notes, as will record of any adjustment to such plan during the course of Treatment.

PATIENT RESPONSIBILITIES

All information provided to us must be true and accurate. You are required to correct any information, which is subsequently identified as incorrect, inaccurate, or incomplete.

You must read and sign any consent forms required in relation to your treatment. You must seek clarification for any document (or part thereof) that you feel is unclear. If you do not agree any part of the forms, you must inform us immediately.

If at any time you withdraw your consent for any (or all) treatment or storage, you must do so by giving written confirmation with such notice delivered in reasonable time.

Some treatments require mandatory counselling and/or mandatory blood tests for screening purposes. You agree to undertake these, and accept that treatment may be delayed until they are completed.

You must notify us in writing of any change in personal circumstances that is relevant to your treatment, consent given by you and/or your partner, or the storage of gametes.

PLACE OF TREATMENT

Unless otherwise agreed between the parties, treatment shall take place at In-OVO Fertility Clinic. In-OVO Fertility Clinic will not give advice, assistance or treatment outside the United Kingdom except by prior agreement.

Where patients attend In-OVO Fertility Clinic having begun treatment, or taken advice elsewhere, In-OVO Fertility Clinic accepts no liability whatsoever for the consequences of that treatment or advice and gives no warranty that such treatment or advice was properly given.

CONFIDENTIALITY

In all matters between the Parties, In-OVO Fertility Clinics Limited will comply at all times with the requirements of The General Data Protection Regulation (GDPR) (EU) 2016/679 (which superseded the Data Protection Act 1998), the Human Fertilisation and Embryology Act 1990, and the HFEA Code of Practice with regard to maintaining the proper standards of medical confidentiality and the handling of personal information of Patients.

FEES AND PAYMENT

The Patient shall pay the fees relevant to the Services and Treatment received as set out in the Price Guide. The total price of which will be agreed between the parties. Payment should be in sterling or Euro (if you wish to pay in Euro please advise in advance). The clinic accepts all methods of payment including cash, debit or credit card (excluding American Express).

In relation to consultation appointments, the Patient shall pay all invoices submitted to them in full and cleared funds, upon booking. We reserve the right to cancel any appointment if payment has not been received in full and cleared funds.

In relation to blood tests not included in Treatment Packages, the Patient shall pay all invoices at the time the test is performed.

Payment of all invoices must be received by In-OVO Fertility Clinic on or before the first day of any Services/Treatment commencing. We reserve the right to cancel or suspend any Services/Treatment if payment has not been received in full and cleared funds at this time.

In-OVO Fertility Clinics Limited reserves the right to amend the prices published in the Price Guide. We will honour any prices in effect at the time the Financial Consent form is signed.

No refunds are due to the patient if Services have been performed.

Refunds to the Patient, per the values in the Price Guide in effect at the time said Treatment was paid for, in respect of Treatment Packages cancelled for medical reasons will be issued within 28 days.

COMMENCEMENT, DURATION AND TERMINATION

Treatment will commence upon meeting certain conditions:

- i. All relevant screening checks of the Patient have been conducted;
- ii. The results have been received by In-OVO Fertility Clinics Limited;
- iii. The Patient does not have a pre-existing medical condition or other factor that would exclude them from meeting criteria for treatment;
- iv. The relevant consent forms have been signed;

The Contract continues for the duration it takes to provide the Services.

Either party may terminate the Contract without liability to the other immediately on giving notice, and without prejudice to any other rights or remedies, which the parties may have, **if:**

- i. The other party commits a breach of any of the terms of the Contract and fails to remedy the breach (where such a breach is remediable) within 30 days of that party being notified in writing of the breach; or
- ii. The other party is subject to any step towards bankruptcy or liquidation; or
- iii. The other party suspends or ceases, or threatens, to carry on all or a substantial part of its business; or
- iv. The other party fails to pay any amount due under the Contract on the date such payment is due.

Upon termination of the Contract, the Patient shall immediately pay any outstanding amounts on their account.

THIRD PARTIES

From time to time, some additional services may be required in the course of your treatment. Where those Services provided by Third Parties are not included within our standard rates, they will be charged at the Third Party provider's rates.

CIRCUMSTANCES BEYOND THE CONTROL OF EITHER PARTY

In the event of any failure by a party because of something beyond its reasonable control, the party will advise the other party as soon as reasonably practicable.

In-OVO Fertility Clinics Limited shall have no liability to the Patient under the contract if it is prevented from, or delayed in performing its' obligations under the Contract or from carrying on its business by acts, events, omissions, or accidents beyond its reasonable control.

WITHDRAWAL

In the event that the patient shall unreasonably refuse to accept or follow advice given by any employee or agent of In-OVO Fertility Clinic, either party may withdraw from the terms of the agreement to provide advice, assistance and treatment and treat itself as discharged from it terms, provided always that the withdrawal be communicated in writing and that reasons for that withdrawal be given.

LIABILITY

In-OVO Fertility Clinics Limited does not exclude liability for:

- i. Any fraudulent act or omission
- ii. Death or personal injury caused by negligence or breach of our other legal obligations.

In-OVO Fertility Clinics Limited are not liable for loss which was not reasonably foreseeable to both parties at the time when the Contract was made.

Subject to this, we hereby set out the entire financial liability of In-OVO Fertility Clinics Limited (including any liability for the acts or omissions of its employees, agents, consultants, and subcontractors) to the Patient in respect of:

- i. Any breach of the Contract;
- ii. Any use made by the Patient of the Services; and
- iii. Any representation, statement or tortious act or omission (including negligence) arising under or in connection with the Contract.

All warranties, conditions and other terms implied by statute or common law are, to the fullest extent permitted by law, excluded from the Contract.

Subject to the conditions in this clause, In-OVO Fertility Clinics Limited's total liability in contract, tort (including negligence or breach of statutory duty), misrepresentation, restitution or otherwise arising in connection with the performance, or contemplated performance, of the Contract shall be limited to the price paid for the Services.

GOVERNING LAW, JURISDICTION, & COMPLAINTS

The proper law for the construction of this agreement is the law of Northern Ireland and the parties hereby irrevocably agree that all disputes, claims, complaints, issues and proceedings arising out of treatment, assistance and advice given at or by In-OVO Fertility Clinic shall be subject to the exclusive jurisdiction of the Courts of Northern Ireland.

The parties hereby agree that all claims for injury, loss or damage connected with or arising out of the advice, assistance and/or treatment given at or by In-OVO Fertility Clinic shall be subject to the laws of Northern Ireland and the exclusive jurisdiction of the Courts of Northern Ireland, howsoever that injury, loss or damage shall be said to have been caused and whatsoever the cause of action raised. We try to avoid any dispute, but if a dispute should arise the Patient should contact us in writing to find a solution.

We follow the Human Fertilisation and Embryology Authority's ("HFEA") Code of Practice, available from www.hfea.gov.uk
